

RENTAL APPLICATION FORM - 2007
W.S.R.C.D. WATER DEVELOPMENT PROGRAM



CONDITIONS:

1. The type of equipment will be at the discretion of W.S.R.C.D. Cost to the applicant will be:

\$700.00 for the first load of pipe (up to 1 1/4 miles)
PLUS
\$250.00 for each additional load of pipe required.

Additional charges will be assessed as follows: (Time is calculated from start up until pipe is ready for transport.)

- (a) Tractor driven pumps - **\$12.50** per hour after 18 hours.
- (b) Gasoline driven pumps - **\$5.00** per hour after 48 hours.

NOTE: Applications received or filled after October 1st may be assessed additional charges if extra transportation costs are incurred.

- 2. Pumping equipment will be allocated by the W.S.R.C.D. dugout filling coordinator.
- 3. The applicant assumes responsibility for arranging at his/her expense for the following:
 - (a) Four persons to lay pipe and pick up the pipe within two hours of the completion of pumping or in the case of night pumping, by 9 a.m. the next morning.
 - (b) Tractors of at least four cylinders in good operating condition, with a 540 r.p.m. power take off (p.t.o.) and a 60 to 100 p.t.o. horsepower (H.P.) to operate the tractor driven pumps. In some cases a 100 p.t.o. H.P. tractor may be required. The pump operator in charge shall have the final say as to suitability and number of tractors required for pumping the dugout.
 - (c) An attendant to be on duty throughout the pumping period.
 - (d) Fuel and oil for the equipment, locating and making arrangements for the pumping source, and crossing of all farm lands, roadways and other obstacles.
- 4. Proper pumping conditions including weather must be maintained to prevent damage to equipment (eg. freezing). **If the client does not follow the guidelines as set out by the pumping supervisor, the client will assume all responsibilities for damage.**
- 5. W.S.R.C.D. pumping units are not to be transferred to any other party or parties without the consent of the W.S.R.C.D. dugout filling coordinator. W.S.R.C.D. reserves the right to withdraw equipment from service at any time.
- 6. W.S.R.C.D. will not be responsible for any accident to any person moving or operating the equipment.
- 7. When required, extra charges will be collected by the pumping supervisor after completion.
